INSTRUCTIONS & GUIDELINES

You must use the official 2010 MVS application. It must be dated and signed by you and your parent(s) or guardian. Typed applications are preferred; however, neatly printed applications are acceptable. An electronic version is available to download at www.elks.org/enf/scholars.

Applications and all supporting documents must be in English or English translations. We highly recommend making photocopies of your application and supporting documentation. All applications become the property of the B.P.O. Elks of the U.S.A. and the Elks National Foundation and will not be returned to you.

This application must be filed with the Elks Lodge in closest proximity of your U.S. permanent address on or before **November 2, 2009**. To find your local Lodge, visit www.elks.org/enf/findalodge.cfm. **DO NOT SEND APPLICATION TO THE ELKS NATIONAL FOUNDATION**—it will be automatically disqualified.

If you are selected to be a National Finalist, you will be required to submit a secondary application online.

ELIGIBILITY

Any high school senior who is a U.S. citizen is eligible. Male and female students compete separately for identical awards.

COMPLETED APPLICATION

Your application must be in a folder with inside pockets and clasps.

Note: Everything, except items in sealed envelopes, should be three-hole punched and placed in the clasps of the folder.

The completed brochure should include the application, transcript, test scores, supplemental materials, counselor report and exhibits.

EMPLOYMENT

List jobs held September 1, 2006, through August 31, 2009. List approximate total hours worked, not average hours per week. You will receive 0 points in this section if you do not list your hours as instructed.

COMMUNITY SERVICE

List community service performed September 1, 2006, through August 31, 2009. List approximate total hours served, not average hours per week. You will receive 0 points in this section if you do not list your hours as instructed.

HONORS AND AWARDS

The following is a list to assist in completion of the Honors and Awards section. Include awards such as Eagle Scout; Gold Award; Teen of the Year; Statewide or National Conferences (ex: Boy's/Girl's State, HOBY); National Merit Finalist; AP Scholar; major athletic award; and major academic award. Obviously, this list is not inclusive.

LEADERSHIP AND EXTRACURRICULAR ACTIVITIES

List your **principal** high school leadership roles and extracurricular activities, the number of years involved, and the hours per week commitment.

Note: Activity sheets are acceptable replacements for the Employment and Community Service, Honors and Awards, and Leadership and Extracurricular Activities sections. These sheets must include all of the information required in those sections.

EXHIBITS

Attach up to 10 pages of exhibits of achievement in scholarship, leadership, athletics, dramatics, community service or other activities. Exhibits may be double-sided.

PARENTAL FINANCIAL INFORMATION

Parent(s) complete the financial information section based on your 2008 IRS 1040. Please note, should the applicant become a National Finalist, a copy of the applicant's 2010 Student Aid Report will be required.

If your parents are divorced or separated, answer the questions for the parent you lived with the most in the past 12 months. If you lived with both parents an equal number of days in the past 12 months, count the parent who provided you with the greatest amount of support, financial as well as material. Material support includes cars, clothing, medical and dental payments, etc. If that parent has remarried, you must include the stepparent's information.

Note: If the family has divorced or separated within the past five years and the custodial parent has not remarried, you must provide financial information of the non-custodial parent. If whereabouts of the non-custodial

parent is unknown or the non-custodial parent is unwilling to comply, please explain in a separate statement.

COUNSELOR REPORT

This report must be completed by your high school guidance counselor or appropriate school official. The report form and school profile (if available) must be secured in a sealed envelope and included with the application.

TRANSCRIPT & SAT/ACT SCORES

Include an official, current high school transcript of student grades. Transcript may be a photocopy that bears the original signature of the proper school authority. The transcript must include 7th semester classes. It does not need to include 7th semester grades.

Either the SAT or the ACT must be taken before October 15, 2009. Test scores must be included in the application, but may be photocopies. The SAT essay score will not be taken into consideration. It is not necessary to send a separate sheet of test scores if the are included on your transcript.

INDEPENDENT STUDENT

We will not accept an applicant as an independent student, unless the student is or has been a ward of the Court. We require a copy of a Court Document or a Notarized letter from an appropriate Court Agency (Social Services) certifying such status.

HOMESCHOOLING

Home-schooled students are eligible to apply for the scholarship. However, all aspects of the application must be filled out completely. When possible, a third party should complete the Counselor's Report for the applicant.

MOST VALUABLE STUDENT AWARDS

Applications must advance through local, district, and state competitions to reach the national competition. A student can apply for, but cannot accept, more than one Elks National Foundation scholarship or grant in any one academic year.

National Finalists will be notified by email in early February 2010. To be eligible for an award, National Finalists are required to submit a secondary application online, which will include an essay, parental financial statement, counselor letter of recommendation, college plans and scholarships/grants/aid/awards received to date. Finalists will also be required to mail their Student Aid Report to the Elks National Foundation office in Chicago. The secondary application must be submitted by March 1, 2010.

National winners will be notified in writing by the Chicago office of the Elks National Foundation in April 2010. All scholarships are in the form of certificates of award issued by the ENF, conditioned upon the enrollment of the student in an undergraduate, four-year degree program in an accredited U.S. college or university. (For the first two years of the four-year program, the student may enroll in a two-year college. Upon receipt of the Verification of Enrollment form from proper school officials, an Elks National Foundation check for the amount of the award will be forwarded to the college or university to establish a credit for the student. Many Lodges, districts and states award their own scholarships through the MVS program. The ENF is only responsible for administering the 500 national awards.
